

# **CAMP 505**

## **RULES AND RENTAL AGREEMENT**

### **ARRIVALS / DEPARTURES**

- Check-in: Oct 2nd – all day; Oct 5th & 8th – between 2pm & 4pm
- Check-out- 10am
- In advance of your arrival, you will receive specific directions to the campsite and parking area along with the Campsite Attendants contact information.
- The Campsite Attendant will be available by phone to help you with directions.
- Upon arrival you will be met by our Campsite Attendant and directed to your parking location.
- You are strongly encouraged to arrive prior to 4pm due to heavy traffic during evening sessions. If you should arrive after 4pm you may encounter heavy traffic and may be prevented from arriving at your site until after the evening session so pre-arrival communication with the Campsite Attendant is important.

### **PORTABLE TOILETS / SHOWER FACILITIES**

- Portable restrooms will be set up on site along with hand washing stations.
- Shower facilities are available at Planet Fitness located .45 miles from Camp. A \$20 daily rate applies.

### **PROHIBITED ITEMS**

- NO DRONES OR ANY OTHER UNAUTHORIZED MOTORIZED FLYING AIRCRAFT ALLOWED if you are caught you will be escorted off the property after a discussion with the FAA & other government agencies.
- Guests must not smoke, cook or allow any open flames, flammable devices within or near the tent.
- Firearms are not allowed at Balloon Fiesta Park.
- Guests must not bring in tents or use the area for car or RV camping.

### **PETS**

- Pets are allowed in Camp 505 but must always be on a leash.
- Owners must clean up pet waste. You will be asked to leave the premises if found not picking up after your pet.
- Animals are ultra-sensitive to the sound of balloon burners and will become frightened when balloons land or fly over the camp. Extra care and consideration should be taken with your pet and for other guests during flying events.
- Pets, other than service animals, are not allowed past the ticket booths when entering the Balloon Fiesta Park.
- We ask that you do not leave your pet unattended at Camp 505 so a contingency plan for your pet's care should be in place if you plan to enter the launch field portion of Balloon Fiesta Park.

### **PLEASE NOTE**

- Balloon Fiesta assumes no responsibility for cancellation of balloon activities due to weather or safety considerations.
- Security will be onsite 24 hours per day throughout the event.
- Balloon Fiesta is not responsible for loss or damage to vehicles or their content.
- Quiet hours are from 10pm—5am.
- Please keep our campsite clean, place trash in provided receptacles.
- You have agreed to follow these rules at the time of booking, please keep in mind these rules are in place for your safety.

**All rentals are subject to the following Terms and Conditions, to which the Guest agrees and accepts:**

- Guest agrees to follow all rules, regulations, and policies of the Balloon Fiesta
- All sales are final with NO refund for cancellations. Under extreme circumstances, and at the sole discretion of Balloon Fiesta, the booking may be transferred to a third party acceptable to BALLOON FIESTA with a \$30 rebooking fee.
- The Guest responsible for booking the rental and agreeing to these terms and conditions must be at least 18 years of age.
- Guests must not smoke, cook or allow any open flames, flammable devices in or near the tent.
- Guest must inspect and assess the condition of all goods upon taking possession and bring to the attention of the Campsite Attendant any goods that are less than tip notch condition.
- Guest will take all necessary precautions and protect all persons and property from injury or damage. Guest agrees to indemnify, defend and hold harmless BALLOON FIESTA, including, but not limited to, attorney's fees and costs, from and against any and all liability claims and judgments of every kind and nature including, but not limited to, injuries or death to persons and damage to property, arising out of the use, maintenance, operation, possession, or rental of the items rented.

BALLOON FIESTA is not liable for injuries or damage to persons or property caused by fire, lightning, windstorm, rain, cyclone, tornado, hail, explosion or any other acts of God.

- Guest agrees to pay BALLOON FIESTA all costs and expenses and reasonable attorney's fees in any action brought to recover the rented merchandise, collect rentals or damages, or in which BALLOON FIESTA may become a party by reason of this Agreement.
- Guest agrees that the items will be used only for the purpose for which the items were manufactured and intended. Guest understands that tents are temporary structures designed to provide limited protection from weather conditions, primarily sun and rain; however, there may be situations, particularly those involving strong winds, in which the tents will not provide protection and may even be damaged or blown over. Evacuation of tents to avoid possible injury is recommended when severe weather threatens the area where the tents are erected. People must leave the tents and not seek shelter in tents during such conditions. It is best to evacuate when in doubt. Guest also understands that tents are not guaranteed to be 100% waterproof and may leak during heavy rain.
